

## ENVIRONMENTAL POLICY

In this context, MPP comprises the design, development, procurement, management, construction, commissioning, operation, and maintenance of turn-key projects.

MPP has developed a robust environmental management system, in accordance with the requirements of ISO 14001:2015 and by acknowledging its responsibilities and obligations towards people and the environment, is committed to achieve the following objectives:

- Protect the environment by prevention of pollution and reduction of undesired effects derived from its activities.
- Continuous improvement of Environmental Management System to enhance environmental performance.
- Compliance with applicable regional, national & international legal & regulatory requirements.
- Becoming carbon neutral by 2050 & taking leadership towards gradual decarbonization, by achieving 30% CO<sub>2</sub> emissions reduction by 2030.

In the light of its Environmental Sensibility and under the umbrella of Mytilineos published Corporate Environmental Policy, MPP defines all the environmental parameters related to its activities and develops systematic processes to reduce its Environmental Footprint, focusing on:
